COMPREHENSIVE GROUP TAKAFUL SCHEME

1. What is this product about?

This is group Takaful Plan, which is designed to provide protection against death and total disablement for members or employees (participants) of the covered of the covered group within the term of the policy with saving element for retirement purposed.

2. What are the Shariah concepts applicable?

- Contract of “Tabarru” - where participants donate a pre-determined percentage of contribution to the risk fund to provide assistance to fellow participants.
- Wakalah model – ensures that participants also benefit from investment and surplus in the risk fund.

Takaful Ikhlas Model allows a bigger portion of the participant’s account to be utilized for investment purposes, which gives a more optimized rate of return. It also provides for more frequent allocation of surplus to the participant’s investment account. Immediate reinvestment of these investment income and surplus will in turn provide a better total return to the participants.

3. What are the covers / benefits provided?

This certificate covers:-

- Death due to Illnesses, Accidents or Natural causes
- Total Permanent Disability due to Illnesses Natural and Accidental causes
- Partial Permanent Disability caused by accidents
- Immediate Death Expenses
- Critical Illness on Acceleration Basis
- Daily Hospital on Acceleration Basic

4. How much contribution do I have to pay?

This plan is per unit basis. Contributions are payable monthly until maturity of the policy. The maturity benefits are accumulated contribution (net of any charges) in the Personal Investment Account (PIA) and Personal Risk Investment Account (PRIA).

For standard type of CGTS cover the minimum contribution is RM10.00 monthly.

5. What are the fees and charges that I have to pay?

6. What are some of the key terms and conditions that I should be aware of?

Importance of disclosure – you must disclose all material facts such as occupation, previous loss experience and your hobbies or hazardous activities that you normally involved in.

7. What are the major exclusions under the certificate?

This certificate does not cover certain losses, such as:

- On death - Should the Participant, whether sane or insane commits suicide, dies as a result of Acquired Immune Deficiency Syndrome (AIDS) or other sexually transmitted diseases or
- self-inflicted injury or any attempt thereat while sane or insane
- military or naval service in time of declared or undeclared war or while under orders for war like operations or restoration of public order; or
- operating or servicing, ascending or descending from or with any aerial device or conveyance except while the Participant is in an aircraft operated by a commercial passenger airline on a regular schedule passenger trip over its established passenger route or when the Participant is a passenger of a fully licensed aircraft or helicopter services operating in areas not serviced by a regular scheduled passenger aircraft; or

- if the Participant is found to be infected by any Human Immunodeficiency Virus (HIV) or Acquired Immune Deficiency Syndrome (AIDS) or other sexually transmitted diseases; or
- If the Participant is under the influence of alcohol or drugs other than in accordance with the direction of a registered medical practitioner.
- if the Participant participates in a riot, or commits a criminal offence.

Note :

8. Can I cancel my certificate?

You can cancel your certificate at any time by giving written notice to the takaful operator. Upon cancellation, you are entitled to a refund of the contribution based on 32.9 % saving (based on the quotation)
