Dear Customer,

This Product Disclosure Sheet (PDS) provides you with the key information on your family takaful.

Other customers have read this PDS and found it helpful; **you should read it too.**



1 What is IKHLAS Ilhamku?

IKHLAS Ilhamku is an endowment takaful product that offers takaful protection for 15 years. The sum covered will be payable to the takaful participant if the person covered passed away during the term of the certificate. This certificate also provides special benefit such as excellence reward, special payout and fund value payout.

The applicable shariah concepts are as follows:

- **Tabarru'** – donation for the purpose of solidarity and cooperation among the takaful participants and to be used to help all takaful participants in times of misfortune or pre-agreed events. The rates will be based on gender, attained age, occupational class rating and other factors. The tabarru' takes into effect when you contribute to the risk fund.
- **Wakalah** – refers to a contract where a party, as principal (*muwakkil*) authorises another party as his agent (*wakil*) to perform a particular task on matters that may be delegated, with or without imposition of a fee. In the context of the company, we are appointed as an agent (*wakil*) to carry out the takaful business and wakalah fee (*ujrah*) to be paid to the company.

Note: "the company" refers to Takaful Ikhlas Family Berhad.

2 Know Your Coverage/Benefits

As an illustration, based on a basic sum covered of RM150,000 and other riders (if any) attached to this plan for a healthy 10 year old male, coverage term 15 years and **RM1,953.00** annually, you will receive the following family takaful benefits:

Death Benefit	RM150,000 + participant's individual fund (PIF) (if any)
Excellent Reward Benefit	Education: RM1,000 Quran Related Study: RM1,500 Skill-Based: RM1,000
Special Payout	RM150 or 10% of participant's individual fund (PIF) value, whichever is higher
Fund Value Payout	The fund value payout of RM5,000 will be payable on the takaful certificate anniversary date when the person covered age next birthday (ANB) is 25.
Simple Payor Rider	Refer to benefit illustration

Your family takaful **excludes**:

- The death benefit shall not be payable should the person covered passed away directly or indirectly as a result of committing suicide whether sane or insane within twelve (12) months from the takaful certificate date or reinstatement date whichever is later.

Other Key Terms

- You must disclose all material facts such as medical condition and state your age correctly. Otherwise, you may risk having your claim rejected or takaful certificate terminated.
- If we do not receive takaful contribution on the contribution due date and provided the amount in the PIF is sufficient, the amount in the PIF will continue to be deducted for tabarru' and certificate charge until the amount in the PIF is insufficient to pay for the charges. In such event, your takaful certificate shall lapse.
- Grace period is thirty-one (31) days from the takaful contribution's due date to pay your takaful contributions.

Note: This list is **non-exhaustive**. You should refer to the takaful certificate for the full list of terms and conditions.

Can I cancel my takaful certificate?

Yes, you may cancel your takaful certificate by giving a written notice to us.

- Cooling-off period:** You may cancel your takaful certificate by returning the takaful certificate within 15 days after your takaful certificate has been delivered to you. The contribution that you have paid (less any medical fee incurred) will be refunded to you.
- Written Notice:** If you find that this plan that you have chosen is no longer appropriate in the future, you may surrender the takaful certificate by giving a written notice to us. The company shall refund the accumulated amount in the PIF, if any, after deducting the surrender fee. The takaful certificate including all attaching riders to this basic plan (if any) will cease thereafter.

The eligible benefits payable under this takaful certificate are protected by PIDM up to limits. Please refer to PIDM's TIPS Brochure or contact Takaful Ikhlas Family Berhad or PIDM (visit www.pidm.gov.my).
