<p>1) What is this product about?</p> <p>This IKHLAS Money Takaful Certificate is designed to cover loss of your money whilst in transit and whilst in the premises.</p>	
<p>2) What are the Shariah concepts applicable?</p> <ul style="list-style-type: none"> • Tabarru' – shall mean donation for the purpose of solidarity and cooperation among the Takaful Participants and to be used to help Takaful Participants in times of misfortune. In the context of the Company, Tabarru' will be allocated into the Risk Fund. • Wakalah – refers to a contract where a party, as principal (<i>muwakkil</i>) authorizes another party as his agent (<i>wakil</i>) to perform a particular task on matters that may be delegated with or without imposition of a fee. In the context of the Company, we are appointed as an agent (<i>wakil</i>) to carry out the Takaful Business and a Wakalah fee (<i>Ujrah</i>) to be paid to the Company. <p>Note: Please refer to the Takaful Certificate for more information.</p>	
<p>3) What are the covers / benefits provided?</p> <p>This Money Takaful Certificate provides 2 forms of cover. You can choose to insure either one or both.</p> <ul style="list-style-type: none"> • Transit Risk - Loss of money outside the premises. This section covers loss of money by the actual destruction, disappearance or wrongful abstraction of money whilst being conveyed by authorized personnel. You have to assess the highest amount for any one carrying as this represents the limit of liability any one event. • Premises Risk - Loss of money inside the premises. This section pays for loss of money within the described premises for money kept in locked safe, strong room and other receptacles. You have to assess the highest amount of money kept in the premises at any one time as this represents the limit of liability any one event. In addition, our Money Takaful certificate also covers the cost of repair or replacement of the safe, strong room or other receptacles up to RM1,000.00 associated with such theft or attempted theft. <p>Note: Duration of cover is for one (1) year. As such, you need to renew your Takaful Certificate annually.</p>	
<p>4) How much Takaful Contribution do I have to pay?</p> <p>The total Takaful Contribution that you have to pay may vary depending on the risk exposure, our underwriting requirements and the limit of liability any one (1) event.</p> <p>Takaful Contribution computation is normally based on dual layered computation, i.e.</p> <p>a) Money in transit is based on Estimated Annual Carrying (EAC)</p>	

b) Money in premises is based on the limit any one event

6) What are some of the key terms and conditions that I should be aware of?

Importance of Disclosure

- You must disclose all material facts that you know or ought to know; otherwise your Takaful Certificate may be invalidated;
- You must take all ordinary and reasonable precaution for the safety of the property covered.
- You must inform your Takaful intermediary or us in writing on any material changes during the Takaful Certificate period so that the necessary amendments are endorsed to your Takaful Certificate.

Surplus

- The Company shall charge a Surplus Administration Charge (SAC) of 50% of the gross distributable surplus arising at the end of the financial year. However, the Company may at its discretion and where appropriate charge SAC less than 50% of the gross distributable surplus. Any net distributable surplus arising (after deducting the SAC) from the Risk Fund will be allocated in full (100%) to the Takaful Participant. If the amount due to Takaful Participant is less than the threshold, the amount shall either be retained in the Risk Fund or donated to charity on behalf of the Takaful Participants. Both the threshold and the treatment of such amount shall be as defined in the Surplus Management Policy.

7) What are the major exclusions under the Takaful Certificate?

This Takaful Certificate does not cover loss or damage caused by arising out of

- War, invasion, acts of foreign enemies, hostilities, or war-like operations (whether war be declared or not), civil war;
- due to robbery or theft by any director partner or employee of the Takaful Participant;
- of Money from machines operated by coins tokens or currency notes;
- destruction or damage directly or indirectly occasioned by pressure waves caused by aircraft or other aerial devices travelling at sonic or supersonic speeds;
- due to the use of counterfeit Money;

- or shortage due to clerical or accounting errors or omissions or to depreciation in value;
- of Money from any vehicle left without an occupant;
- or destruction of or damage to Money being sent by post;
- destruction or damage directly or indirectly caused by or contributed to by or arising from nuclear weapons material.

Note : *This list is non-exhaustive. Please refer to the Takaful Certificate for the full list of exclusions under this Takaful Certificate.*

8) Can I cancel my Takaful Certificate?

You may cancel your Takaful Certificate by giving written notice to us. Upon cancellation, you are entitled to a refund of the pro rata Takaful Contribution for the unexpired period of cover. No refund of Takaful Contribution is allowed if there is a claim under the Takaful Certificate.

9) What do I need to do if there are changes to my contact details?
