1. What is this product about?

This rider provides comprehensive protection against Death, Total and Permanent Disability (TPD), Partial and Permanent Disability (PPD), Total and Temporarily Disability (TTD) and Partial and Temporarily Disability (PTD) caused solely and directly by accident(s) within the term of the Takaful Certificate.

In addition to the above, Takaful Participant is also entitled for Medical Surgical Expenses Reimbursement (MSER) or Outpatient Medical Reimbursement Benefit (OMRB) caused solely and directly by accident(s) within the term of the Takaful Certificate.

2. What are the Shariah concepts applicable?

- **Tabarru'** – shall mean donation for the purpose of solidarity and cooperation among the Takaful Participants and to be used to help Takaful Participants in times of misfortune. In the context of Takaful IKHLAS, Tabarru' will be allocated into the Risk Fund.
- **Wakalah** – shall mean agency. In this context, it refers to a contract between the Company and the Takaful Participant where the Takaful Participant authorises the Company to manage the fund on his/her behalf, which allows the Company to charge a Wakalah fee.

3. What are the covers / benefits provided?**a) Death or Total and Permanent Disability (TPD)**

In the event of accidental death or TPD of the Takaful Participant within the term of the Takaful Certificate, the Takaful Benefit and the amount accumulated in the PRIA, inclusive of investment income from the PRIA and net distributable surplus from the Risk Fund, if any, will be payable to the Takaful Participant's beneficiaries or next of kin (in the event of death) or to the Takaful Participant (in the event of TPD).

Conditions:

TPD is based on "Any Occupation" definition and the benefit is payable subject to an elimination period of six (6) months, provided that:

- The TPD claim is confirmed
- The Takaful Contributions are not overdue

b) Partial and Permanent Disability (PPD)

In the event of PPD of the Takaful Participant solely and directly by bodily injury resulting from accidental cause within the term of the Takaful Certificate, the percentage of Sum Covered as stated below, less any amount payable under TTD and PTD benefits as a result of the same accident shall be paid to the Takaful Participant.

The aggregate of all percentages payable in respect of any accident shall not exceed 100%. In the event of a total of 100% having been paid, the Supplementary Takaful Certificate hereunder shall immediately cease to be in force. All other compensation lesser than 100% if already paid shall reduce the coverage proportionately by that amount paid from the date of accident until the expiration of the Takaful Certificate.

c) Medical Surgical Expenses Reimbursement (MSER)

If the Takaful Participant is confined into hospital and undergo the Surgery* due to bodily injury from the accident within 24 hours from time of injury, Takaful Participant can submit claim on the medical expense and any reasonable and necessary cost paid by the Takaful Participant to Medical Practitioner and/or registered hospital. Reimbursement will be up to 5% of the Takaful Benefit per accident.

Note: The surgery is defined as minor and major surgeries as guided by the MMA Schedule of Fees 4th Edition 2002 or newer.

d) Total and Temporarily Disability (TTD)

If the Takaful Participant sustains TTD for at least seven (7) consecutive days as a result of accident, a weekly benefit equal to 0.6% of the Takaful Benefit and proportionately thereof per day is payable to the Takaful Participant during the disability period from the date of accident. Maximum number of weeks covered is up to fifty-two (52) weeks for any one accident and this benefit is not applicable if the Takaful Participant is unemployed or a full time student.

TTD shall mean disablement which entirely prevents the Takaful Participant from attending to his business or occupation of any kind. It will be based on the assessment by the Company appointed medical advisor.

e) Partial and Temporarily Disability (PTD)

If the Takaful Participant sustains PTD for at least seven (7) consecutive days as a result of accident, a weekly benefit equal to 0.2% of the Takaful Benefit and proportionately thereof per day is payable to the Takaful Participant during the disability period from the date of accident. Maximum number of weeks covered is up to fifty-two (52) weeks for any one accident in total for both TTD & PTD and this benefit is not applicable if the Takaful Participant is unemployed or a full time student.

PTD shall mean disablement which prevents the Takaful Participant from attending to a substantial part of his business or occupation but which shall not render him under Total Temporary Disablement. It will be based on the assessment by the Company appointed medical advisor.

f) Outpatient Medical Reimbursement Benefit (OMRB)

If the Takaful Participant is received an outpatient treatment on the bodily injury resulted from the accident within twenty-four (24) hours from the time of injury, Takaful Participant can submit claim on outpatient medical treatment expenses and any reasonable and necessary cost has been paid by the Takaful Participant to Medical Practitioner and/or registered hospital*. Reimbursement will be up to 1% of the Takaful Benefit per accident.

Note: Hospital means accident and emergency unit of government hospitals/clinics and private hospitals/clinics that is registered with Ministry of Health under the Private Healthcare Facilities and Services Act 1998 - LAWS OF MALAYSIA.

g) Takaful Certificate Maturity Benefit

Lump sum amount equivalent to the amount accumulated in the PRIA, inclusive of investment income from the PRIA and net distributable surplus from the Risk Fund, if any, is payable upon maturity.

h) Takaful Certificate Surrender Benefit

Lump sum amount equivalent to the amount accumulated in the PRIA, inclusive of investment income from the PRIA and net distributable surplus from the Risk Fund, if any, net off all charges, is payable upon the surrender of the Takaful Certificate.

4. How much Takaful Contribution do I have to pay?

The total Takaful Contribution that you have to pay depends on the underwriting requirements, age, term, and Sum Covered. Your Takaful Contribution is as follows:

The renewal Takaful Contribution is not guaranteed and Takaful IKHLAS reserves the right to revise the Takaful Contribution rate applicable specifically to each Takaful Participant at the time of Takaful Certificate anniversary based on the emerging claims experience of the portfolio. Takaful IKHLAS shall give the Takaful Participant a three (3) months written notice in the event of revision of Takaful Contribution or product withdrawal. The Takaful Contribution could be revised due to deterioration in claims experience, changes in the product benefits as well as a change in the risk profile of the Takaful Participant. These conditions are not exhaustive and the Takaful Contribution rates may be reviewed under other justified circumstances.

5. What are the fees and charges that I have to pay?

a) Wakalah Fees

* The Wakalah fee is inclusive of the commission.

b) Tabarru' charge is deducted from the PRIA. Tabarru' will increase as the Takaful Participant and/or Payor grow older.

Note : The charges imposed by Takaful IKHLAS may not include any future taxes (including the Goods and Services Tax (GST)). Upon implementation of the GST, Takaful IKHLAS has the right to recover from the Takaful Participant any taxes required by law.

6. What are some of the key terms and conditions that I should be aware of?

- Importance of disclosure - you must disclose all material facts such as your age, occupation and health condition correctly. Takaful IKHLAS has the right to repudiate liability in the event that you failed to disclose relevant information that would affect the decision to accept or reject the risk, and on the terms to be applied to you.
- Cooling-Off Period - you may cancel your Takaful Certificate by returning the Takaful Certificate within fifteen (15) days after you have received the Takaful Certificate. The Takaful Contribution that you have paid (less any medical charges - if any) will be refunded to you. The Company shall cancel the Takaful Certificate immediately upon receipt and shall be deemed not effective from the date of issuance.
- Amount accumulated in the PRIA - The actual investment income may fluctuate based on market conditions. As a result, the amount accumulated in the PRIA may rise above or fall below the total Takaful Contribution made into PRIA (possibly leading to early Takaful Certificate lapsation).
- Investment profit arising from PRIA, if any, shall be returned to the Takaful Participant (through PRIA) after deducting an Investment Performance Fee of 30% from the profit. However, the Company may at its discretion deduct less than 30% from the profit as Investment Performance Fee.
- The Company will charge a Surplus Administration Charge (SAC) of 50% of the gross distributable surplus declared at the end of each Financial Year. The net distributable surplus (after deducting SAC) from the Risk Fund will be allocated in full (100%) to the Takaful Participant.
- It is important for you to receive receipts and keep them as proof of payment of Takaful Contributions.
- If you do not receive the Takaful Certificate after fourteen (14) days from the date of participation, please contact us.
- Notification of claim must be given in writing to the Company within thirty (30) days after occurrence of any claim. The Company, upon receipt of notice of claim, will furnish to the claimant appropriate forms for filing proof of claim and shall notify the claimant of any other requirements. This shall not preclude the Company from requiring further documentation in respect of the loss as deemed fit by the Company. All such information and evidence must be furnished to the Company within ninety (90) days from the date of the events covered.

Note: This list is non-exhaustive. Please refer to the Takaful Certificate for the terms and conditions under this Takaful Certificate.

7. What are the major exclusions under the Takaful Certificate?

This Supplementary Takaful Certificate shall not cover any death or disability caused directly or indirectly, wholly or partly, by any one of the following occurrences:

- a) Committing, attempting or provoking an assault or a felony or any violation of the law by the Takaful Participant;
- b) riot and civil commotion, strikes or terrorist activities;
- c) suicide or any attempt thereof or self-inflicted injury while sane or insane;
- d) war, declared or undeclared, revolution or any warlike operations;
- e) military or naval service in time of declared or undeclared war or while under orders or warlike operations or restoration of public order;
- f) making an arrest as an officer of the law;
- g) violation or attempted violation of the law or resistance to arrest;
- h) racing other than on foot;
- i) accident occurring while or because the Takaful Participant is affected by the consumption of alcohol beyond the permitted limit or drug unless taken as prescribed by a qualified medical practitioner;
- j) illness or disease of any kind due to hernia, ptomaines or bacterial infection (except pyogenic infection which shall occur with and through an accidental cut or wound);
- k) inhalation of poison, gas or fumes (voluntarily or involuntarily taken);
- l) entering, operating, or servicing, ascending or descending from or any other activities relating to and including sky diving, parachuting, bungee jumping, hand-gliding and ballooning or any other aerial device, contraption, conveyance except while the Takaful Participant is in an aircraft operated by a commercial passenger airline on a regular scheduled passenger trip over its established passenger route;
- m) Any act of terrorism. For this purpose an act of terrorism means an act, including but not limited to the use of force or violence and/or threat thereof, of any person or group(s) of persons, whether acting alone or on behalf of in connection with any organization(s) or government(s), committed for political, religious, ideological or similar purposes including the intention to influence any government or organization and/or to put the public, or any section of public in fear;
- n) Illness, injury or other losses occurring before the payment of the initial contribution, or whilst the Takaful Certificate is in a state of lapse;
- o) All kinds of diseases; pregnancy, childbirth or any form of miscarriage;
- p) Use of prototype engines.

Any hospitalization outside of Malaysia shall not be covered under this Supplementary Takaful Certificate.

Note: This list is non-exhaustive. Please refer to the Takaful Certificate for the full list of exclusions under this Takaful Certificate.

8. Can I cancel my Takaful Certificate?

Participating in a family Takaful plan is a long-term financial commitment. If you do not pay your Takaful Contributions within the grace period, your Takaful Certificate may lapse. The cash amount that the Takaful operator will pay you when you cancel the Takaful Certificate before the maturity period will be much less than the total amount of Takaful Contribution that you have paid.

9. What do I need to do if there are changes to my contact details?

It is important that you inform us of any change in your contact details to ensure that all correspondences reach you in a timely manner.
